The Protection Profile identified in this report was assessed according to the *Assurance Continuity: CCRA Requirements*, version 1.0, February 2004. The baseline for this assessment was the Certification Report and the Evaluation Technical Report of the product certified by the Federal Office for Information Security (BSI) under BSI-CC-PP-0030-2008.

The change to the certified Protection Profile is at the level of editorial changes that have no effect on assurance. The identification of the maintained Protection Profile is indicated by the introduction of a version number as compared to the certified Protection Profile. The changes are related to minor orthographical corrections and adaptations to a new revision of the TPM specification.

Consideration of the nature of the change leads to the conclusion that it is classified as a minor change and that certificate maintenance is the correct path to continuity of assurance.

Therefore, the assurance as outlined in the Certification Report BSI-CC-PP-0030-2008 is maintained for this version of the Protection Profile. Details can be found on the following pages.

Assessment

The IT product identified in this report was assessed according to the *Assurance Continuity: CCRA Requirements* [1]. The baseline for this assessment was the Certification Report of the certified product (Target of Evaluation, TOE) [2] and the Evaluation Technical Report [7].

The Protection Profile [3] was changed due to orthographical corrections, as well as some adjustments to a new revision of the TPM specification [4-6]. Configuration Management procedures required a change in the product identifier. Therefore the version number changed from 1.1 to 1.2 [8].

Conclusion

The change to the TOE is at the level of orthographical corrections and adaptation to a new revision of the specification [4-6] that have no effect on assurance. Consideration of the nature of the change leads to the conclusion that it is classified as a minor change and that certificate maintenance is the correct path to continuity of assurance.

Therefore, BSI agrees that the assurance as outlined in the Certification Report [2] is maintained for this version of the product. This report is an addendum to the Certification Report [2].
