The IT product identified in this report was assessed according to the *Assurance Continuity: CCRA Requirements*, version 2.1, June 2012 and the developer's Impact Analysis Report (IAR). The baseline for this assessment was the Certification Report, the Security Target and the Evaluation Technical Report of the product certified by the Federal Office for Information Security (BSI) under BSI-DSZ-CC-0596-V2-2018 updated by BSI-DSZ-CC-0596-V2-MA-02.



The change to the certified product is at the level of firmware improvements. The identification of the maintained product is indicated by a new version number compared to the certified product.

Consideration of the nature of the change leads to the conclusion that it is classified as a <u>minor change</u> and that certificate maintenance is the correct path to continuity of assurance.

The resistance to attacks has <u>not</u> been re-assessed in the course of this maintenance process. Therefore, the assurance statement as outlined in the Certification Report BSI-DSZ-CC-0596-V2-2018 dated 25 September 2018 is of relevance and has to be considered when using the product. #### **Assessment**

The IT product identified in this report was assessed according to the *Assurance Continuity: CCRA Requirements* [1] and the Impact Analysis Report (IAR) [2]. The baseline for this assessment was the Certification Report of the certified product (Target of Evaluation, TOE) [3], its Security Target and the Evaluation Technical Report as outlined in [3].

The vendor for the Mobiles eHealth Kartenterminal ORGA 930 M online, V4.8.0:1.0.0, Ingenico Healthcare GmbH, submitted an IAR [2] to the BSI for approval. The IAR is intended to satisfy the requirements outlined in the document *Assurance Continuity: CCRA Requirements* [1]. In accordance with those requirements, the IAR describes (i) the changes made to the certified TOE, (ii) the evidence updated as a result of the changes and (iii) the security impact of the changes.

The Mobiles eHealth Kartenterminal ORGA 930 M online, V4.8.0:1.0.0 was changed due to keep up with the requirements from the gematik specification (Release OPB3.1.2/OPB3.1.3 aus 2019 / 2020 zur Produktypversion (PTV) V1.4.0) which require to change the choice for VSDM asymmetric encryption algorithms (from PKCS1\_V1\_5 to OAEP) and to prohibit the use of generation 1 (G1+) electronic health cards. Further, optimisations and bug fixes in the course of product maintenance and code re-factoring were performed by the developer. Configuration Management procedures required a change in the product identifier. Therefore the version number changed from version V4.7.0:1.0.0 to version V4.8.0:1.0.0. The Security Target was editorially updated. The changes are related also to an update of the user guidance [4].

#### Conclusion

The maintained change is at the level of implementation. The change has no effect on product assurance.

Consideration of the nature of the change leads to the conclusion that it is classified as a minor change and that certificate maintenance is the correct path to continuity of assurance.

The resistance to attacks has <u>not</u> been re-assessed in the course of this maintenance process. Therefore, the assurance statement as outlined in the Certification Report BSI-DSZ-CC-0596-V2-2018 dated 25 September 2018 is of relevance and has to be considered when using the product.

### Obligations and notes for the usage of the product:

All aspects of assumptions, threats and policies as outlined in the Security Target not covered by the TOE itself need to be fulfilled by the operational environment of the TOE.

The customer or user of the product shall consider the results of the certification within his system risk management process. In order for the evolution of attack methods and techniques to be covered, he should define the period of time until a re-assessment for the TOE is required and thus requested from the sponsor of the certificate.

Additional Note: The strength of the cryptographic algorithms was not rated in the course of the product certification and this maintenance procedure (see BSIG<sup>1</sup> Section 9, Para. 4, Clause 2).

For details on results of the evaluation of cryptographic aspects refer to the Certification Report [3] chapter 9.2.
