INTRODUCTION

According to the CCRA (Common Criteria Recognition Arrangement) requirements regarding the assurance continuity outlined in [AC] and considering the impact analysis report [IAR] provided by Dell Technologies, Inc., the updated version Dell EMC VxRail Appliance 4.0 with VxRail Manager v4.0.400-6628128 on 160, 160F, E460, E460F, P470, P470F, V470F, V470F, or S470 maintains the assurance gained in the original TOE certification Dell EMC VxRail Appliance with VxRail 4.0.400-6628128 on 160 and Dell EMC VxRail Appliance with VxRail 4.0.400-6628128 on 160F.

The baseline for this maintenance have been the certification report [INF-2342], the security target [STEOR], the Evaluation Technical Report [EXT-3895] from the original certified TOE referenced by the file number 2016-46, and the impact analysis report [IAR] from the updated TOE referenced by the file number 2018-56.

As the changes in the maintained TOE have been considered as minor changes, the conclusion is that the maintained TOE is appropriate for assurance continuity and therefore a re-evaluation is not required. It must be stated that no additional evaluation testing has been performed by the evaluation lab during the maintenance process.

This report is considered as an addendum to the Certification Report [INF-2342]. The following section describes the information regarding the identification of the Impact Analysis Report [IAR] of the maintained TOE and the declared changes as outlined in [AC].

Changes to the TOE

Some new hardware models have been included within the scope of the certificate, concretely the models: E460, E460F, P470, P470F, V470, V470F and S470.

These new hardware models do not affect the certified security properties of the original TOE as the hardware models are security irrelevant considering the declared TSF in [STEOR]. The software component within the scope of the certificate remain unchanged.

The VxRail 160 and VxRail 160F hardware models were tested as part of the certified TOE evaluation by Epoche & Espri S.L.U.

A complete set of regression tests have been run against the Changed TOE has been performed by the TOE developer for this maintenance request.
